# 23/01985/FUL Burway House, 3 Westholme Park, Hazler Road, Church Stretton, Shropshire, SY6 7AF

Erection of a front porch

The Town Council supports the application to erect a front porch at this modern property, which other than for the fact that it sits within the Church Stretton Conservation Area would surely have been a permitted development. The new porch is unlikely to have any detrimental effect on the neighbour opposite whose property sits considerably higher than the applicants.

23/00933/FUL Burway Cottage, Burway Road, Church Stretton, Shropshire, SY6 6DP. Erection of 1No wooden Shepherds Hut

The Town Council is neutral on this application but has the following comment. The applicant states that parking for guests using the Shepherds Hut will be in front of the garage. On visiting the property prior to the committee meeting there was construction ongoing that looked like this parking area may not be available. There is plenty of on-street parking close to the property so this may not be too problematic. The application is for one Shepherds Hut. Church Stretton Town Council accepts that suitable accommodation for visitors is in short supply, but we would ask that the Local Planning Authority consider adding a planning condition on this property that ensures no future applications to increase the numbers of Shepherd Huts is granted due to the lack of parking and location of Burway Cottage on this very steep road.
