The smaller authority has confirmed that it has not complied with the governance Assertion in Section 1, Box 4, but it has provided the appointed auditor with an adequate explanation for non-compliance and details of the actions necessary to address weaknesses identified.
The smaller authority has not been able to provide one of the year-end bank statements to support the bank reconciliation to Section 2, Box 8. These were requested as part of our intermediate review procedures. The Buckinghamshire Building Society does not issue statements and we have therefore been unable to verify the year end balance for that account.
